## Session 2: Technical Department Update on Call for Evidence and Corporate Net Zero Standard Revision Process

#### Purpose of the session:

**For Information** - SBTi Chief Technical Officer to provide an update on Call for Evidence and Corporate Net Zero Standard Revision status and planned process.

#### Summary:

SBTi CTO provided an overview of the planned process for revision of the SBTi Corporate Net-Zero Standard, which encompasses a review of Scope 3 target-setting and a review on the use of Environmental Attribute Certificates (EACs) in SBTi standards.

The assessment of the effectiveness of Environmental Attribute Certificates (EACs) encompasses certificates that convey emission factors (e.g. RECs) as well as certificates that convey mitigation outcomes (e.g. carbon credits). The initial focus of the analysis is on carbon credits. Subsequent assessment is planned for other instruments.

The consultation draft for the Corporate Net-Zero Standard is tentatively scheduled to be presented for the TC to be reviewed for approval in Q3 2024. The TC will be regularly updated on the process of developing this standard.
